Images of work submitted will not be  
returned and if accepted by judge  
may be used for PR purposes.  
Selected pieces must be available for  
the entire show. All artwork must  
have a declared value for insurance  
purposes. If not for sale, note NFS  
along with the value.

## **ELIGIBILITY**

Open to artists 18 years of age and  
older, living in the southeast regions  
of the United States.

All forms of painting, drawing,  
sculpture, photography, graphics  
and ceramics are accepted.  
Pieces must be original and entirely  
the work of the artist. Pieces should  
not exceed 65 inches in any  
direction, including the frame.  
Installations are not eligible.  
Entries that have won an award in a  
previous ADSO exhibition are not  
eligible.

Work that differs from the original  
image submitted will not be  
accepted. No changes in the title,  
sale price or value may be made after  
the selection process. Accurate,  
legible information is to be provided  
with the application. Work that differs  
from the original image submitted

the title, sale price or value may be

provided with the application.  
*All artwork must have a declared  
value for insurance purposes.*

## **STANDARDS**

Accepted entries must be ready for  
gallery installation. Framed, two-  
dimensional pieces must be  
appropriately matted; a white or off-  
white quality mat board preferred.  
The use of colored or black mats as  
the primary mat is discouraged.  
Heavy, ornate frames are not  
acceptable. Heavy wire attached  
securely to the back of the frame

with screw eyes or track mounting clips are  
acceptable. Plexiglas only.  
Three dimensional pieces must be able to be  
handled comfortably by two people. Any piece  
requiring assembly must be assembled by the  
artist at a time arranged with ADSO.

## **LIABILITY**

ADSO and the NW Florida State College, their  
officers, employees, directors, members,  
volunteers or anyone connected with the  
exhibition will not be liable for damages. We  
suggest artists carry their own insurance for  
this purpose. Damaged shipping containers  
will be returned unopened. Signature on entry  
form indicates agreement with these conditions

## **DELIVERY**

shipments must comply with UPS or FedEx
